Member Garcia said her concern is whether it is an internal process to ensure that we spend the dollars that will expire \$t. She asked what will happen to the \$1.8 million remaining balance. Ms. Ramos replied that this is one of the three allocations for learning loss mitigation. It has a later expiration date and has not yet been committed. Member Garcia then asked w\\$\gamma20,000 in the unrestricted general fund that was spent on professional development could not be covered with CARES Act dollars.
