



- 13. <u>Headings</u>. The headings of the paragraphs of this Purchase Contract are inserted for convenience of reference only and shall not be deemed to be a part hereof.
- 14. <u>Effectiveness</u>. This Purchase Contract shall become effective upon the execution of the acceptance hereof by the District and by the County by the respective authorized officer of each, and shall be valid and enforceable at the time of such acceptance.
- 15. <u>Counterparts</u>. This Purchase Contract may be executed in several counterparts, which together shall constitute one and the same instrument.
